RESOLUTION

**AMENDING RESOLUTION #18-16 REGARDING THE DESIGNATION
OF THE TIME OF COUNCIL MEETINGS FOR THE YEAR 2016**

WHEREAS, pursuant to the New Jersey Open Public Meetings Act and §3-8 of the Code of the City of North Wildwood, Council adopted Resolution #18-16 on January 5, 2016, designating the time and place of Council Meetings during the Year 2016; and

WHEREAS, §3-8 states that Council may amend or modify the resolution designating the time and place of meetings by adopting a subsequent resolution; and

WHEREAS, Council does feel at present that the meetings held on the first Tuesday of each month should be moved to an earlier time than 7:00 p.m.

THEREFORE, BE IT RESOLVED, by Mayor and Council of the City of North Wildwood, in the County of Cape May and State of New Jersey that regular meetings of the City Council during the remainder of the year 2016 shall be held at City Hall, 901 Atlantic Avenue in the City of North Wildwood and shall be scheduled as follows:

1) The first Tuesday of every month at 5:00 p.m., prevailing time, immediately preceded by a caucus meeting of Council at 4:00 p.m., prevailing time.

2) The third Tuesday of every month at 10:00 a.m., prevailing time, immediately preceded by a caucus meeting of Council at 9:00 a.m., prevailing time.

BE IT FURTHER RESOLVED, that if any of the aforementioned meeting days falls on a legal holiday, then the meeting that was scheduled for the legal holiday shall not be held on the legal holiday but, rather, shall be held on the first succeeding weekday that is not a legal holiday.

BE IT FURTHER RESOLVED, that the August 2, 2016 meeting, although occurring on the first Tuesday of the month, will begin at 10:00 AM, preceded by a caucus meeting of Council at 9:00 a.m., so as to not conflict with National Night Out activities.

BE IT FURTHER RESOLVED, that, from time to time, there may be a need for special meetings and emergency meetings as may be deemed necessary by Mayor and Council for the transaction of business and, upon being advised of the need for such a meeting, the City Clerk shall publish and post notification of such a meeting in accordance with the requirements established by the Open Public Meetings Act and such other laws and regulations as may be applicable.

BE IT FURTHER RESOLVED, that the schedule of Council Meetings attached hereto as Exhibit A shall be published in the Official Newspapers of the City, placed on the City's website, and posted on the City Clerk's Bulletin Board for the remainder of the Year 2016.
