### **RESOLUTION**

#### **RESCHEDULING JUNE 3, 2020 and JULY 7, 2020 COUNCIL MEETING DATES and TIMES**

**WHEREAS**, the Annual Meeting Schedule of City Council, adopted by Council via Resolution #17-20 on January 7, 2020, states that Meetings of City Council shall be held on the first Tuesday of every month at 5:00 PM and the third Tuesday of every month at 10:00 AM, except in the case of holidays, in which the Meetings would be held on the first succeeding weekday after the holiday; and

**WHEREAS**, due to the Primary Election in the State of New Jersey scheduled to be held on Tuesday, June 2, 2020, the first regular meeting of City Council of the City of North Wildwood in the month of June was scheduled to be held on Wednesday, June 3, 2020, to begin at 5:00 PM with a caucus meeting at 4:00 PM; and

**WHEREAS**, according to said Annual Meeting Schedule, the first regular meeting of City Council of the City of North Wildwood in the month of July was scheduled to be held on Tuesday, July 7, 2020, to begin at 5:00 PM with a caucus meeting at 4:00 PM; and

**WHEREAS**, due to the current state of emergency resulting from the COVID-19 pandemic, Governor Murphy issued Executive Order #120 on April 8, 2020, which, in part, postponed the June 2, 2020 Primary Election in the State of New Jersey and rescheduled the same to Tuesday, July 7, 2020; and

**WHEREAS**, since there will be no Primary Election held on Tuesday, June 2, 2020, Council deems it appropriate to reschedule the first regular meeting of the month of June from Wednesday, June 3, 2020 to Tuesday, June 2, 2020, to begin at 5:00 PM with a caucus meeting at 4:00 PM; and

**WHEREAS**, since the Primary Election will now be held on Tuesday, July 7, 2020, Council deems it appropriate to reschedule the first regular meeting of the month of July from Tuesday, July 7, 2020 to Wednesday, July 8, 2020; and

**WHEREAS**, Council deems it appropriate that, although occurring on the first Tuesday of the month, the regular meeting rescheduled to Wednesday, July 8, 2020 will begin at 10:00 AM, preceded by a caucus meeting of Council at 9:00 a.m., so as to not conflict with the regularly scheduled meeting of the North Wildwood Planning Board which will occur that evening.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of North Wildwood, in the County of Cape May, State of New Jersey, that:

1. All of the statements of the preamble are repeated and are incorporated herein by this reference thereto as though the same were set forth at length.
2. The Wednesday, June 3, 2020 regular meeting of City Council is hereby rescheduled to be held on Tuesday, June 2, 2020, to begin at 5:00 PM, with caucus meeting at 4:00 PM.
3. The Tuesday, July 7, 2020 regular meeting of City Council is hereby rescheduled to be held on Wednesday, July 8, 2020, to begin at 10:00 AM, with caucus meeting at 9:00 AM.
