## RESOLUTION

### ESTABLISHING HOURS FOR BICYCLE RIDING ON BOARDWALK PURSUANT TO ORDINANCE 1811

**WHEREAS**, Ordinance 1811, adopted by Council on July 8, 2020, amends §150-2A of the Code of the City of North Wildwood to indicate that the hours during which bicycle riding on the Boardwalk is permitted shall be established from time to time by resolution of City Council; and

**WHEREAS**, in an effort to coordinate with the current bicycle hours in the City of Wildwood, Council deems it appropriate to allow bicycle riding on the North Wildwood Boardwalk each day until 1:00 PM.


**NOW, THEREFORE, BE IT RESOLVED** by Council of the City of North Wildwood, in the County of Cape May and State of New Jersey as follows:


- 1) All of the statements of the preamble are incorporated herein by this reference thereto as though the same were set forth at length.
- 2) It shall be unlawful during the period commencing June 15 of each year through September 14 of each year for any person to ride a bicycle on the Boardwalk or its approaches from 1:00 PM to 5:00 AM, inclusive, daily.
- 3) The hours established by the terms of this resolution shall be posted on the City's website, on the bulletin board in City Hall, and at other appropriate places as determined by the City Clerk.
- 4) The Director of Public Works shall take all actions necessary and proper regarding the installation of appropriate signage at various places on the North Wildwood Boardwalk.
- 5) The City Clerk shall maintain a copy of this resolution in the Ordinance 1811 file.
- 6) The hours established by the resolution shall be in effect until modified by a subsequent resolution of Council.
- 7) The effective date of this Resolution shall coincide with the date upon which Ordinance 1811 becomes effective.
