REGULAR MEETING FEBRUARY 2, 2021 5:00 PM

A regular meeting of the North Wildwood City Council was held in the evening of the above date in the City Hall. The President pro tempore of Council stated, "The meeting is now open. Adequate notice of this meeting has been provided by posting a copy of the notice of the time and place of this meeting on the City Clerk's bulletin board and by mailing a copy of the same to The Herald, The Press and Wildwood Leader on January 6, 2021."

ROLL CALL: Present were Mayor Patrick Rosenello, President *pro tempore* of Council Kellyann Tolomeo, Councilpersons David Del Conte, Margaret Bishop and Joseph Rullo. Councilman Edwin Koehler was present via telephonic conference call. President of Council Salvatore Zampirri and Councilman James Kane were not present. Also present were City Administrator Ronald Simone, Solicitor Michael Donohue and Engineer Ralph Petrella.

<u>PRESENTATION:</u> North Wildwood United Methodist Church- "Homeless Jesus" statue

Pastor Kate Aaronson of the North Wildwood United Methodist Church stated that the Church will be installing a statue titled "Homeless Jesus" on the Central Avenue side of the Church. This was explained in a letter which was previously provided to Mayor and Council. After the Church's merger with the Wildwood Crest congregation, the Church is more of a year-round church, with an average of 70 people attending in person or by telephone each week. The "Homeless Jesus" statue is found throughout the world, including the Vatican; Pastor Kate saw it in Madrid on a recent trip. It will be an attraction for the foot traffic in the area of the Church, which is very close to the Hereford Inlet Lighthouse.

Pastor Kate's letter to Council:

Dear Mayor Rosenello and Council Members:

As the new pastor of North Wildwood Methodist Church, I requested the opportunity to present the details of a new project in which the Church is engaged to City Council and am on the agenda on February 2, 2021. I appreciate Council's time and consideration.

The Church is planning to install Timothy Schmalz' sculpture, *Homeless Jesus*, on its property on Central Avenue in early summer. *Homeless Jesus* is a visual translation of Matthew 25. Inspired by Jesus' words to his disciples in Matthew 25, "what you do unto the least of these...you do unto me," *Homeless Jesus* suggests that Christ is with the most marginalized in our society and serves as a challenge to remember and show compassion for those in our community who are in need. Found in major cities throughout the world, including outside the Vatican in Rome, in front of Methodist Central Hall in London (across from Westminster Abbey), and in Sydney, Singapore, Belfast, New York and several other American cities, nearly one hundred of the sculptures have been installed. Our target date to unveil the sculpture is Memorial Day weekend.



REGULAR MEETING FEBRUARY 2, 2021

Homeless Jesus is a deeply moving and thought-provoking piece. I encountered Homeless Jesus in Madrid outside of the Almundena Cathedral. From a distance I honestly thought it was a real person asleep on the bench. It was not until I got closer to it that I realized it was a bronze sculpture and then discovered the feet protruding from the blanket. The feet bear deep gashes, the marks of crucifixion. The face of the statue is deliberately concealed, so that everyone can connect and identify with the Jesus it portrays.

Simultaneous with the unveiling of the sculpture, the Church is launching a Homeless Jesus Fund. Last year, the Church donated more than \$16,000 to local organizations such as Lazarus House Food Pantry and Family Promise. We are hoping to increase our support for those agencies and others and provide those who are moved to compassion upon seeing the sculpture the opportunity to support the organizations in our community who are doing the work to provide for those experiencing food insecurity or other hardship. North Wildwood Methodist has been providing for those in our community for 120 years and this project is a way for our little church to form deeper relationships with our partnership organizations and those in our community as well as share the love of God with others.

Below is the proposed design for the placement of the sculpture. You will see it is envisioned to include paved area in which people are invited to approach the sculpture and the sculpture itself invites people to sit and reflect. The bench provides enough space for someone to sit, should they so choose.



These are extraordinary times and the Church hopes this area will be a place of solace for our neighbors and those visiting North Wildwood. The Church is working with Zoning and Planning to ensure our final plan complies with the applicable ordinances and we are grateful to Mr. Spiegel for all of his assistance in this process.

I look forward to the opportunity to speak with all of you on February 2, 2021.

This Ordinance has been published according to Law, posted on the City Clerk's bulletin board with copies available in the City Clerk's Office on request.

The President *pro tempore* of Council stated this was the time and place to hold a public hearing on Ordinance No. 1823 and asked if anyone present had any objections to the passage of this Ordinance. Hearing none, he then asked the City Clerk if he had received any objections in writing, the City Clerk stated none, the President *pro tempore* of Council declared the hearing closed.

On a motion by Bishop, seconded by Rullo, that Ordinance No. 1823 be passed on its second reading and published according to Law, the roll being called, all voting in the affirmative, the President *pro tempore* of Council declared Ordinance No. 1823 duly adopted.

PUBLIC:

NELSON DICE, 1145 Central Avenue, Ocean City, stated that under the rules and regulations of the Methodist Church, he was entitled to a trial in the Church; the matter should not have been handled by a government civil or criminal court. The rules that John Wesley set down for the organization of the Methodist Church mirrored those of the Federal Government. The result of the matter being handled the way it was has been a loss of freedom of worship. The Church has committed a crime by not holding the trial in the Church. Most people refuse to discuss the matter due to not wanting to offend the Holy Spirit. The evidence presented to Judge Belasco should have been reviewed by a Church court.
