A regular meeting of the North Wildwood City Council was held in the evening of the above date in the City Hall. The President pro tempore of Council stated, "The meeting is now open. Also present were City Administrator Ronald Simone, Solicitor Michael Donohue and Engineer Ralph Petrella.

Police Department:

MAYOR ROSENELLO stated that Chief Stevenson has recommended a fine officer to fill a vacancy in the Police Department.
