The City Clerk read Ordinance No. 1860 by its title, as required by Law, known as "An Ordinance Amending And Supplementing Chapter 418, Vehicles And Traffic, Of The Code Of The City Of North Wildwood".

This Ordinance has been published according to Law, posted on the City Clerk's bulletin board with copies available in the City Clerk's Office on request.

CITY CLERK JETT stated that the main points of this ordinance are:

- 1. Beginning in the summer of 2022, paid parking will be expanded to the entire length of both Ocean and Surf Avenues. Surf Avenue from 2nd to 15th is new, while paid parking has been authorized on Ocean Avenue for a long time but it has never been fully implemented there before.
- 2. Weekly and Non-Transferrable Parking Permits have been discontinued.
- 3. The price of Low Speed Vehicle Parking Permits will be \$200 for Summer 2022. Prices will increase in the future as follows:
 - \$300 in 2023
 - \$400 in 2024
- 4. The price of Transferrable Parking Permits will be \$300 for Summer 2022. Rates will increase in the future as follows:
 - \$400 in 2023
 - \$500 in 2024
- 5. Parking with a permit on the east side of John F. Kennedy Beach Drive is now permitted.
- 6. Parking with a permit in any of the City's parking lots is now permitted.
- 7. The owner of a property with a driveway is now permitted to park in front of his/her own driveway, as can anyone else with the owner's permission.

REGULAR MEETING FEBRUARY 15, 2022 The President of Council stated this was the time and place to hold a public hearing on Ordinance No. 1860 and asked if anyone present had any objections to the passage of this Ordinance. Hearing none, he then asked the City Clerk if he had received any objections in writing, the City Clerk stated that he received two items of correspondence objecting to the adoption of this ordinance in writing, and read them both.

Dear Mayor Rosenello and members of North Wildwood City Council:

I am a second home owner in North Wildwood since 2007. I do NOT and have never rented my home. I am writing to you regarding the proposed changes to Ordinance 1860 affecting the type and cost of parking passes in North Wildwood. I ask that you table final approval of Ordinance 1860 in favor of making a directed and sincere, yet quick, effort to re-study the issues and obtain feedback from your community. I for one only learned of the proposed changes this week through Facebook. I have also made some suggestions for consideration near the end of my letter (page 3). I ask that this letter be made part of the official record.

First, a MAJOR problem are the motels and hotels along JFK Boulevard and within the first one or two blocks of the beach. These motels are buying transferable passes and then giving them out to their renters so the renters have more than the one parking space that most motels provide. Some hotels/motels don't have enough parking for all the rooms they have so, again, they buy these passes and hand them out. These renters then park their cars and don't move them for a week or more, taking up valuable parking with almost no cost to themselves or the hotel/motel owners.

I know this is happening because I had a Facebook exchange with one of the hotel owners who said the increase is nothing and people should just pay it. Well, it is nothing for her. For one room, she can take \$300 and divide it over 22 weekly renters for a cost of just \$13.63 additional per week per renter. That is nothing to a vacationer. But it is unfair to taxpayers and frankly outrageous. The City is losing valuable revenue, and parking is being consumed throughout the summer through this abuse of the system. Additionally, the hotel/motel owners themselves actually don't pay anything because they pass this low cost on to their renters.

•Please consider the following: (1) create a different tier of passes for the hotels/motels that is much higher than \$300 and is such a rate to reflect the number of times they are giving these passes out to different renters to use throughout the summer; OR (2) make hotels/motels ineligible for parking passes and reinstitute weekly, non-transferable passes for those visitors using hotels/motels (You could establish an online system for this just as you have for tax and sewer payments); OR (3) if council prefers to do away with weekly and non-transferable passes, make hotels/motels ineligible for passes and let renters at these facilities fight for parking and pay for it through the meters as the rest of us will have to do. See my suggestions at the end of my letter.

Second, similarly, another major problem with parking is the homeowners who DO rent their homes and buy just one transferable pass for \$175 and give it to each renter all summer, instead of requiring the people renting to buy a non-transferable, weekly pass. There are 22 weeks between May and September 30. That means that a person renting his or her home can expend just \$175 and provide 22 weekly renters a pass for no additional money. THAT is an issue–not just for the City but an issue in the way of fairness to those of us who do not rent. I don't know what a weekly pass used to cost, but

•I ask that you reconsider eliminating them and requiring people who have registered to rent their homes to buy non-transferable, weekly passes for EACH week they rent their home or condo (they could get the license plate number from the renter) or require the renters themselves to do so. You could establish an online system for this just as you have for tax and sewer payments.

Third, people like myself who do not rent their homes are generally not a problem with parking but will bear the brunt of the increase in costs or at least the unfairness of what is being proposed. I have off street parking, and I try to walk to the beach whenever I can, but I have a bad hip and back and so sometimes it is better for me to drive, especially since I live on the other side of New Jersey Avenue.

•I ask that you consider a parking pass at a lower cost for any resident/second home-owner, who can show they have not registered to rent their home. Some type of increase from \$175 is fair but as high as others pay? That concerns me greatly.

Fourth, the planning board and city have been approving extensive building construction consisting many times of multi-family units on what were once single family lots. An employee in the planning office told my husband last year that the city intended to allow as many units to be built as possible in order to create more taxpayers. However, as a result you have created a parking situation all over the island that will have people at each other's throats for

parking spaces and will eventually drive people from our beaches and towns.

•I would suggest that when a building is proposed for construction in the future that impact on parking is considered in that application.

Finally, such an issue as parking passes affects all homeowners in North Wildwood, many of whom have only found out this information through social media. I only found out about it through Facebook this past week. The NW webpage had no announcement regarding this changes or a request for input, and in fact, the proposed changes are not even attached to the agenda. I worked in public education for 38 years and we had a board of directors. We always had to attach documents so the public could review the proposed changes and have an opportunity to review and comment on them. In North Wildwood you have not done that and so many homeowners are not aware of the changes that will impact them greatly. Therefore,

•Please table Ordinance 1860 in order to re-visit and re-study the issues and options and allow more people to have input to the changes

•Please post these proposed changes to the agenda and to the website in order to alert people and allow them to provide input.

I believe the elimination of non-transferable and weekly passes is short-sighted. In fact, what should be eliminated are the transferable passes. They reduce much needed revenue for the city and invite abuses. With non-transferable passes, The City would recover parking fees more commensurate with the parking being used, and second, it would eliminate the unfairness and abuse of the system that the hotels/motels and homeowners/condo owners who rent are getting away with. Finally, a lower cost pass for homeowners who do not at all rent their homes would be much more fair.

A possible tiered system eliminating transferable passes might look like this:

<u>Tier 1</u> - Homeowner's/Condo owners who do not rent - Nontransferable pass per vehicle–perhaps \$210 (that's a 20% increase for 22 weeks over the \$175)

<u>Tier 2</u> - Homeowner's/Condo owners who do rent - Non-transferable, weekly passes per vehicle for each renter paid by either the homeowner/condo owner or the renter per vehicle. System can be set up like for taxes/sewer payments. Perhaps \$50 per week? (that's about \$7 per day or half of what they would pay through a meter). Plus, the City would recover \$1,100 per household rented for the summer vs. just one \$300.

<u>Tier 3</u> - Hotel/Motel Owners - I'd suggest either (1) they be ineligible to purchase and require renters to obtain a weekly, non-transferable pass (could use a system set up like tax and sewer payments –perhaps \$50 per room per week paid by renter) OR (2) charge the hotel/motel owners a cost per room X 22 weeks as one fee. For example, a motel with 100 rooms would be charged for argument purposes: \$50 per week X 100 rooms X 22 weeks = \$110,000. That sounds like a lot of money, but the owners can and WILL charge each weekly renter just one \$50 fee for all week parking (\$7 per day–half of what they'd pay through the meters) and the owner will recover that money. It is much more commensurate with the parking the hotels and motels are using and certainly more fair to every other resident and visitor in town that pay their fair share through the meters or parking passes instead of

abusing the system as the hotels and motels are doing now. This could also be optional. If the renter doesn't want a parking pass, then they don't have to buy one.

As I said, I myself always walk to the beach when I can, but I purchase a pass because I have a bad hip and back that eventually will need surgery, and I live on the other side of New Jersey Avenue so I have a long walk to the beach and back. I sometimes need to drive when my hip and back are bothering me. I'm also extremely concerned and upset that Council is not addressing the unfair issue of the hotels/motels and homeowners who rent their homes/condos.

I do understand changes have to be made, but I also think there are situations and options that Council has not considered nor do the current proposals address the abuse of the system as I have described above. Therefore, again, I ask that proposed changes to Ordinance 1860 be tabled and the issue revisited and studied through March.

I will try to be at the meeting on Tuesday at 10 AM to voice these views in person, but I have a scheduled doctor's appointment and don't know if I will be done in time to get there. I would like this letter to be made part of the official record.

Thank you in advance for your consideration, and again, I ask that you table Ordinance 1860 until you can consider some other options as I have suggested above and perhaps others that you have received.
