WHEREAS, the first floor of the Borough Hall at 3rd and Central Avenues housed the Fire Company's equipment until the building caught fire in 1922, after which a new City Hall was built at 9th and Pennsylvania (now Atlantic) Avenues; and

WHEREAS, the Anglesea Fire Company then occupied the building at 3rd and Central Avenues until dedicating its new building at 2nd and New Jersey Avenues in 1971; and

WHEREAS, the Anglesea Fire Company No. 1 has continued throughout its history to protect life and property in the City; and

WHEREAS, the Anglesea Fire Company No. 1 has also assisted neighboring municipalities numerous times when called on to fight fires, bringing recognition and honor to its members and the community; and

WHEREAS, the Anglesea Fire Company No. 1 has been active in fundraising efforts throughout its history and has been instrumental in bringing festivals and events to the City's Entertainment District, including the New Jersey State Barbecue Championship for many years; and

WHEREAS, for its contributions to the welfare of the Borough of Anglesea and now the City of North Wildwood, Mayor and Council feel it prudent and appropriate to adopt this Resolution to express gratitude to the Anglesea Fire Company No. 1 for its long period of the service to the community and to express to the Company its best wishes for the future.

<u>CITY CODE BOOK LEGAL/EDITORIAL CODE REVIEW AND ANALYSIS PROPOSAL:</u>

CITY CLERK JETT stated that General Code, the company that compiles and maintains the City's Code Book, has submitted a proposal for a legal and editorial review of the entire City Code. It is recommended that this be done periodically, such as every 15 years; North Wildwood's Code has not gone through such a review in more than 40 years. This review will not only check for internal inconsistencies within the Code; it will also check the Code for any inconsistencies with State statutes. The cost is approximately \$8,000, which will be covered in the budget of the Office of the City Clerk (barring any emergencies). Since Council is the entity that introduces and adopts ordinances, the City Clerk asked for Council's authorization to proceed with this legal and editorial review.

On a motion by Bishop, seconded by Rullo, the roll being called, all voting in the affirmative, that the City Clerk be authorized to proceed with the legal and editorial review and analysis of the City Code as proposed by General Code. The President of Council declared the proposal duly authorized and adopted.
