That each apartment or dwelling for which a permit is issued under this section shall comply with the provisions of the New Jersey Housing Code, shall be kept in a safe, clean and sanitary condition, shall have proper and adequate light and ventilation, and shall be subject to inspection by the Construction Official of the City of North Wildwood, or said Officials and/or the Health Officers of the City of North Wildwood, during reasonable hours in order that said officials might ascertain if said apartment or dwelling complies with the provisions of this Ordinance.

3. That compliance with all appertaining State Statutes and Local Ordinances is required, including P.L. 22, c. 92, regarding the submission of proper Certificates of Insurance to the municipality for business and rental properties.
