Congratulating The 1st Baptist Church Of Anglesea On Its 125th Anniversary

WHEREAS, the Hereford Inlet Lighthouse was the meeting place for Baptist worshippers during the early period of settlement of the area known as Anglesea; and

WHEREAS, the first religious services on Five Mile Beach were held in the Lighthouse in 1878; and

WHEREAS, the need for a formal place of worship became evident, and on February 26, 1898 a group of worshippers met in the home of Freeling H. Hewitt to discuss the organization and incorporation of the Church; and

WHEREAS, the proposal met favorably with the group, and at a subsequent meeting on March 24, 1898 the First Baptist Church of Anglesea was formally incorporated, with a Certificate of Incorporation duly filed with the State of New Jersey and the Cape May County Clerk; and

WHEREAS, the original charter members of the Church included: Freeling and Abilene Hewitt; Edward and Cornelia Shivers; Thomas and Martha Corson; Samuel and Nora Buck; Robert and Delta McCarty; Margaret Mace; Elizabeth Ware; Mary Hilton; and Walter Shivers; and

WHEREAS, the Church members built a chapel at the southeast corner of 3rd and Pennsylvania (now Atlantic) Avenues, which chapel was dedicated on August 9, 1899; and

WHEREAS, in the 125 years since its organization the First Baptist Church of Anglesea has been a landmark symbol of faith, harmony and religious strength in the community.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of North Wildwood, in the County of Cape May and State of New Jersey that:
