REGULAR MEETING JUNE 20, 2023 10:00 AM

A regular meeting of the North Wildwood City Council was held in the morning of the above date in the City Hall. The President of Council stated, "The meeting is now open. Adequate notice of this meeting has been provided by posting a copy of the notice of the time and place of this meeting on the City Clerk's bulletin board and by mailing a copy of the same to The Press of Atlantic City and The Cape May County Herald on January 4, 2023."

<u>PRESENTATION:</u> Crosstrees Condominiums, 801 Ohio Avenue – Request for Removal of Deed Restriction (John Amenhauser, Esq.)

SOLICITOR DONOHUE reviewed the requirements for removal of deed restrictions under N. J. S. A. 40:60-51.2, including the holding of a public hearing.

ATTORNEY AMENHAUSER stated that his client, the Crosstrees Condominium Association, seeks to have the deed restriction removed regarding the maintenance of an earthen berm buffer and associated vegetation on the rear of their property facing the yard of the Department of Public Works. The actual deed restriction, imposed on the property on November 28, 1984, does not specifically state the reason for the restriction. Members of the Association would like to place storage sheds in the area where the buffer now exists. Planning Board approval for the sheds will be needed as well as Council approval for the removal of the restriction.

ENGINEER PETRELLA stated that the buffer requirement was imposed due to the fact that the property backs up to the Public Works yard and it was felt that the buffer would minimize the impact of equipment, supplies and materials, and the general appearance and sounds of a typical public works facility.

<u>PUBLIC HEARING, RE:</u> Proposed Removal of Deed Restriction, Crosstrees Condominiums, 801 Ohio Avenue.

The President of Council stated this is the time and place to hold a public hearing on the proposed removal of the deed restriction on the Crosstrees Condominiums property and asked if anyone present had any objections to the removal of this deed restriction. No comments were offered by the public. The President of Council then asked the City Clerk if he had received any objections in writing, the City Clerk stated none. On a motion by Rullo, seconded by Kane, that the public hearing be closed. Carried. The President of Council declared the hearing closed.
